Narrative: Yorktown Police report the arrest of 24 year old Nadeem H. Abualteen of Yonkers NY who is charged with Criminal Possession of Stolen Property Fifth Degree, a Class A Misdemeanor, Criminal Possession Of Stolen Property Fourth Degree, a Class E Felony and assorted Traffic Violations.

According to police on January 12th 2012 at approximately 6:35pm a call was received from a patron of Staples reporting a suspicious male possibly attempting to enter vehicles in the parking lot. Officers Justin Foley, Kenneth Sgroi and Det. Patsy Perrotto responded to the scene and observed an alleged suspicious male, identified as Nadeem H. Abualteen sitting in a parked vehicle. Further investigation revealed that Abualteen was allegedly in possession of a stolen NY State drivers license, and stolen Macy's credit card which were stolen in Peekskill NY on an earlier date.

Abualteen was arrested at the scene and transported to police headquarters. Following processing on the aforementioned charges, Abualteen was arraigned by Judge Iagonia who remanded him to the Westchester County Jail on \$5,000.00 bail. Abualteen is scheduled to answer said charge in Yorktown Court on January 17th 2012 at 6:00pm.
